## 2.1.2 Translated copy of letter indicating reserved category:

- 12 Reservation- As per the following reservation rules of Government of Chhattisgarh
- 12.1 The reservation of seats in admission to each academic session and its extent in an Educational Institution shall be in the following manner, namely
  - (a) out of the annual permitted strength in each branch of study or faculty, 32% shall be reserved for the Scheduled Tribes
  - (b) out of the annual permitted strength in each branch of study or faculty, 12% seats shall be reserved for Scheduled Castes
  - (c) Out of the annual permitted strength in each branch of study or faculty, 14% seats shall be reserved for the other Backward Classes.

Provided that where the seats be reserved for Scheduled Tribes remain vacant due to non-availability of eligible students on the cut-off date(s), the same shall be filled from among eligible students belonging to the Scheduled Castes and vice versa.

Provided further that where seats reserved under clause (a), (b), (c) remain vacant on cut off date(s) even after the arrangement referred to in foregoing provision the same shall be filled from another eligible student.

- 12.2 (1) The reservation of seats provided under clause (a), (b), (c) of section 3 shall be determined vertically.
  - (2) The percentages of horizontal reservation in respect of persons with disabilities, women, ex-service, personnel, words of freedom fighters, or other special categories of person shall be as are notified for the purposes of this Act by the State Government from time to time, and shall be made within the vertical reservation under clause (a), (b) and (c) as the case maybe, of Section 12.1.
- 12.3 3% seats of the sanctioned seats shall be reserved for son/Daughter/grandson/granddaughter of freedom fighter.

5% seats of the sanctioned seats shall be reserved for persons with disability (PWD)30% seats are reserved for girls' candidates in each category

- 12.5 Any candidate belonging to the reserved category is eligible for unreserved seat on the basis of merit, he/she shall be given admission in UR category and this seat shall not be deducted from the available seat under reserve category If the percentage of reservation is less than ½, then the reserved seat will not available. Number of reserved seats will be 1 if the percentage of reservation seat will be within ½ and 1.
- 12.7 5% seats of the sanctioned seats shall be reserved for son/ daughter/ of migrants of Jammu & Kashmir and 10% relaxation will be provided in minimum marks.
- 12.8 Reservation rules issued by the government from time to time should be followed.
- 12.9 The provisions of reservation shown in 12.1 will be subjected for decision by Honourable High Court of Bilaspur.

12.10 Regarding third gender persons, Strictly follow the instructions given by Honourable Supreme court in case no. W.P(C) 400/2012 in Legal Services authority vs Government of India and others "We direct the centre and State government to take steps to treat them as socially and educationally backward classes of citizen and extend all kinds of reservation in cases of admission in educational institution and for public appointments".
